In Illinois, you must report accidents that result in injury, death, or [property damage exceeding \\$1,500](#). The police record and investigation will also be helpful for your claim.

### Gather Evidence

Take photos of the accident scene, showing your injuries, damage to all vehicles, and road conditions. Write down the contact information of witnesses and the parties involved.

### Notify Insurance Company

Report the accident to your insurance company as soon as you can.
