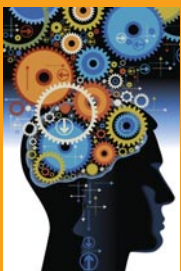

Dr. Wafa Y. Dahdal, Pharm.D., BCPS is Director of International Programmes and Associate Director of Professional Development at the American College of Clinical Pharmacy (ACCP). In this position, she oversees recertification programmes for board certified specialists in pharmacy, publications, and international programmes. Prior to joining ACCP, Dr. Dahdal was professor of pharmacy practice and pharmacotherapy specialist. She has extensive experience in clinical pharmacy, initiating services and providing care to patients in the acute care (adult medicine and critical care) and ambulatory care settings across various specialty areas. As professor of pharmacy practice, Dahdal assumed leadership positions in curricular development, learning methodologies, and assessment as well as the professional development of practitioners and pharmacy practice faculty members.

Dr. Dahdal has published and presented internationally on issues related to cardiovascular medicine, clinical pharmacy services, curricular reform, abilities-based education, professional standards and pharmacy education, and clinical practitioner and pharmacy practice faculty development.

Dr. Dahdal has assumed several professional leadership positions including President of the Gateway College of Clinical Pharmacy and President of the Illinois Chapter of the National Arab American Medical Association. She currently serves a second term as Secretary of the Academic Pharmacy Section and member of the Board of Pharmaceutical Practice of the International Pharmaceutical Federation (FIP). Most recently, Dahdal served on FIP's Working Group on Defining Responsible Use of Medicines.



Dr. Karen J. McConnell, Pharm.D., FCCP, BCPS (AQ Cardiology), is Clinical Pharmacy Specialist in Cardiology, at Kaiser Permanente of Colorado, Clinical Associate Professor at the University of Colorado Skaggs School of Pharmacy and Pharmaceutical Sciences, and Adjunct Professor of Pharmacy Practice at Regis University School of Pharmacy. Dr. McConnell earned her Doctor of Pharmacy degree from the University of Missouri-Kansas City in 1999. She then completed two postdoctoral residency programmes: a pharmacy practice residency at Cox Medical Center in Springfield, Missouri, and a specialty residency at Kaiser Permanente in Denver, Colorado.

Dr. McConnell is Board Certified Pharmacotherapy Specialist with added qualifications in Cardiology. In her current role, she provides clinical consults to cardiologists and other healthcare providers, as well as managing the amiodarone monitoring service. Previously, she was a clinical pharmacy specialist for the Clinical Pharmacy Cardiac Risk Service for 10 years, where she managed cardiac risk factors, such as hypertension and dyslipidemia, for patients with coronary artery disease.

Dr. McConnell has published numerous peer-reviewed articles and given several presentations at state and national professional meetings. She has also served as primary investigator on several research studies at Kaiser Permanente. Her research focus is on cardiovascular care and continuing professional development. Dr. McConnell received Teacher of the Year award for the Kaiser Foundation Health Plan Colorado Region in 2007 and Paper of the Year award from the Cardiology Practice and Research Network of the American College of Clinical Pharmacy in 2010. She became a fellow of the American College of Clinical Pharmacy in 2013.
